ORDINANCE NO 1039

AN ORDINANCE AMENDING CHAPTER XV, ARTICLE 2, SECTION 15-225 OF THE CITY CODE OF THE CITY OF GREENSBURG, KANSAS, BY FIXING AND ESTABLISHING MONTHLY WATER RATES FOR THE SALE OF WATER TO ALL CONSUMERS BY THE WATER DEPARTMENT OF THE CITY OF GREENSBURG, KANSAS, ADDING NEW SECTION 15-226 AUTHORIZING MODIFICATION OF WATER RATES BY RESOLUTION OF THE GOVERNING BODY, REPEALING ORDINANCE NO. 1006 AND ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERING BODY OF THE CITY OF GREENSBURG, KANSAS:

SECTION 1. Section 15-225 of the Code of the City of Greensburg, Kansas, is hereby amended as follows:

“15-225 WATER USE CHARGES

- (a) The following monthly rates for the sale of water to all consumers within the City of Greensburg, Kansas by the Water Department of the City of Greensburg, Kansas , shall be charged and collected in accordance with the following rate schedule pertaining thereto:

Residential and Church Customers:

- (1) Minimum monthly fee of \$14.80 per month:
- (2) For the first 7,000 gallons used, or portion thereof, a fee of \$2.40 per 1,000 gallon:
- (3) For all water used in excess of 7,000 gallon, a fee of \$2.70 per 1,000 Gallon.

Commercial Customers:

- (1) Minimum monthly fee of \$17.80 per month;
- (2) For the first 7,000 gallons used, or portion thereof, a fee of \$2.60 per 1,000 gallons.

- (3) For all water used in excess of 7,000 gallons, a monthly rate of \$3.00 per 1,000.
- (b) The following monthly rates for the sales of water to all consumers outside the City of Greensburg, Kansas by the Water Department of the City of Greensburg, Kansas, shall be charged and collected in accordance with the following rate schedule pertaining thereto:
 - (1) Minimum monthly fee of \$17.80 per month:
 - (2) For the first 7,000 gallons used, or portion thereof, a fee of \$2.75 per 1,000 gallons.
 - (3) All water used in excess of 7,000 gallons, a monthly rate of \$ 3.10 per 1,000 gallons."

SECTION 2. Section 15-226 is hereby added to Chapter XV, Article 2 of the code of the City of Greensburg, Kansas, as follows:

"15-226 MODIFICATION OF CHARGES

After passage of this Ordinance, rates, fees and charges for water may be modified and established by Resolution of the Governing Body of the City of Greensburg, Kansas."

SECTION 3. That Ordinance No. 1006 and all Ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. That this Ordinance shall take effect and be in force from and after July 1, 2013, following its passage and publication in the official city paper, The Kiowa County Signal.
